Credit Line and Terms of Payment

4. In the event that it becomes necessary for Bannerz to refer the account to a collection agency and/or attorney, all reasonable collection and legal fees are to be paid by this debtor. The customer agrees that the Courts of the Province of Alberta will have jurisdiction to hear and determine any actions by Bannerz Canada Inc. for recovery of amounts owing.
